- Once applications have been submitted to the high schools, some high schools may have additional requirements and information needed from those applying. Please check with the school of choice regarding any further information needed.
- **3.** Students must attend Academic Assessment Day on **Saturday**, **January 11**, **2025**, at the high school listed on the bottom of this form (*Selected High School*). On that day, the high school will collect from students a non-refundable, non-transferable, one-time **\$30.00** application fee payable to that high school. Academic Assessment Day at each school will begin at or before 8:30 am. Look for information from the high school selected regarding site-based specific information.
- **4.** All folders of non-accepted students will be forwarded to the Department of Catholic Education and Faith Formation, 7887 Walmsley Avenue, New Orleans, Louisiana.
- **5.** Your signature on the reverse authorizes and permits other Catholic high schools (that may have openings) to review your child's student records in the event that the *Selected High School* does not accept your child's application. Please make sure to complete both pages of this form.
